During the 14 DAY bidding period prior to this date, a total of 7 contractors became Bidders of Record and 5 submitted sealed bids. The bid opening was conducted by Legat architects and witnessed by 5 attendees. Refer to the attached Bid Tabulation and Attendance Record.

Legat Architects has reviewed the qualifications and references of the 1 low bidder and have found no evidence which would disqualify the apparent low bidder, LZ Design Build Group, from being awarded the contract for all work.

In addition to the Base Bid, Bidders were required to identify the amounts for 2 alternate bids. Accepting alternate numbers 1 and 2 is not being recommended currently.
